7.5 (v) is an alien who is illegally or unlawfully in the United States;

7.6 (vi) has been discharged from the armed forces of the United States under dishonorable

7.10 (viii) is disqualified from possessing a firearm under United States Code, title 18, section
7.11 922(g)(8) or (9), as amended through March 1, 2014;

7.12 (11) a person who has been convicted of the following offenses at the gross misdemeanor
7.13 level, unless three years have elapsed since the date of conviction and, during that time, the
7.14 person has not been convicted of any other violation of these sections: section [609.229](#)
7.15 (crimes committed for the benefit of a gang); [609.2231](#), [subdivision 4](#) (assaults motivated
7.16 by bias); [609.255](#) (false imprisonment); [609.378](#) (neglect or endangerment of a child);

8.12 **Subd. 15. Penalties.** (a) Except as otherwise provided in paragraph (b), a person who
 8.13 does any of the following is guilty of a gross misdemeanor:

8.14 (1) transfers a pistol or semiautomatic military-style assault weapon in violation of
 8.15 subdivisions 1 to 13;

8.16 (2) transfers a pistol or semiautomatic military-style assault weapon to a person who
 8.17 has made a false statement in order to become a transferee, if the transferor knows or has
 8.18 reason to know the transferee has made the false statement;

8.19 (3) knowingly becomes a transferee in violation of subdivisions 1 to 13; or
 8.20 (4) makes a false statement in order to become a transferee of a pistol or semiautomatic
 8.21 military-style assault weapon knowing or having reason to know the statement is false.

8.22 (b) A person who does either of the following is guilty of a felony:

 9.6 the person knows that the transferee:

9.7 (1) has been denied a permit to carry under section [624.714](#) because the transferee is
 9.8 not eligible under section [624.713](#) to possess a pistol or semiautomatic military-style assault
 9.9 weapon;

9.10 (2) has been found ineligible to possess a pistol or semiautomatic military-style assault
 9.11 weapon by a chief of police or sheriff as a result of an application for a transferee permit
 9.12 or a transfer report; ~~or~~

9.13 (3) is disqualified under section [624.713](#) from possessing a pistol or semiautomatic
 9.14 military-style assault weapon; ~~or~~
